

Terms and Conditions of Entry for the West End Burley Football (Promotion)

1. These terms and condition of entry, including information on how to participate and prize details (**Terms**), apply to the Promotion and entry into the Promotion is deemed acceptance of these Terms.
2. The Promoter is Hotel & Club Services Pty Ltd (ABN 86 067 065 338) of 540 Port Road, Allenby Gardens SA 5009 on behalf of EDP Hotel Group (**Promoter**).

4. The Promotion will be open from 7am on 1 April 2018 until 11pm on 30 April 2018 (**Promotion Period**).

(Promotion Period).

5. Entry in the Promotion is only open to South Australian residents:
 - (a) aged 18 years and over; andexcluding:
 - (b) management, employees, directors and contractors of the Promoter, its related bodies corporate, the Participating and other agencies, firms or companies associated with the Promotion (including suppliers of prizes);
 - (c) a spouse, de-facto spouse, parent, guardian, child or sibling of a person referred to in paragraph 5(c) of these Terms;
 - (d) persons who have breached the terms and conditions of any promotion run by or on behalf of the Promoter,

(Eligible Entrants). The persons referred to in paragraph 5(b) of these Terms includes natural and non-natural relations (in the opinion of the Promoter) and the Promoter is responsible for determining whether a person is an Eligible Entrant in its absolute discretion.

HOW TO ENTER

6. To enter and be eligible to win, Eligible Entrants must, during the Promotion Period:

- (a) Purchase either a schooner, pint or imperial pint of West End Draught
- (b) Scan their EDP Eureka Rewards Card (an **Eligible Entry**). Non members may participate by joining the EDP Eureka Rewards at anytime during the promotion. See staff for details.

DRAW AND PRIZES

In total there are 30 Burley West End Footballs valued at \$100 each.
Each participating venue will conduct two draws from the Eligible Entries entered from their venue.
These draws will draw two winners who will win a Burley West End Football.

Each participating venue will conduct a first and second chance manual random prize draw.

The First chance draw

The winner of the first chance draw prize will win a Burley West End Football valued at \$100.

The Second chance draw

The winner of the second chance draw prize will win a Burley West End Football valued at \$100.

The draws will be conducted at each participating venue by a representative of the Promoter at 11:00am on 02 May 2018. The participating venue draws will be all the Eligible Entries from their participating venue during the Promotion.

The Draw winner will be notified by telephone and email within 48 hours of the draw and published on the EDP Hotel rewards website www.edphotels.com.au within 7 days of the draw.

The prize will be available for collection from the participating venue that the draw was held at. It is the winners responsibility to collect the prize within 3 months of the winner being notified.

VERIFICATION

- 7. If requested by the Promoter, the Prize winner must produce, within the time requested by the Promoter at its absolute discretion appropriate photo identification or other documentation, required by the Promoter to verify their identity, age, eligibility to enter the Promotion and claim the and compliance with these Terms, before the Promoter issues their Prize. If the items required by the Promoter are not received or a provisional winning entry has not been verified to the satisfaction of the Promoter within the time period required by the Promoter, the provisional winner's entry will be invalid and, at the Promoter's absolute discretion, all of the provisional winner's remaining entries will be invalid. Prizes will only be awarded following all validation and verification requirements of the Promoter being met to its satisfaction.
- 8. If more than one person attempts to claim the Prize, the Promoter has sole and absolute discretion to determine which of those persons is the winning Eligible Entrant.

GENERAL

- 9. The makers of West End Draught (Lion - Beer, Spirits & Wine Pty Ltd) are not involved in or responsible for the organisation or conduct of this promotion. All participant inquiries should be directed to the promoter and not to Lion - Beer, Spirits & Wine Pty Ltd.
- 10. Each Qualifying Purchase counts towards one entry only.
- 11. Eligible Entrants may enter the Promotion as many times as they wish provided;
 - (a) each entry is based on a separate Qualifying Purchase; and
 - (b) is submitted separately in accordance with these Terms.
- 12. Eligible Entrants can only enter the Promotion in their own name.

13. Prizes are not transferable, exchangeable or redeemable for cash. Prizes must be taken as offered and may not be varied.
14. The Promoter shall not be liable for the Prizes being lost, stolen, damaged or tampered with in any way before it reaches the winner.
15. The Promoter accepts no responsibility for any variation in the value of the Prize.
16. If the Promoter is unable to provide the winner with the nominated Prize, the Promoter reserves the right to supply an alternative prize of similar monetary value to the nominated prize, subject to any directions given by the Office of the Liquor and Gambling Commissioner, South Australia.
17. The Promoter accepts no responsibility for any entries not received for any reason during the Promotion Period. No responsibility will be taken for lost, late or misdirected entries. The Promoter does not warrant that the entry mechanism will be available, or the Participating will be open, at all times during the Promotion Period.
18. If, for any reason, the Promotion is not capable of being run as planned, including due to tampering, unauthorised intervention, fraud or any other causes beyond the control of the Promoter, which corrupt or affect the administration, security, fairness, integrity or proper conduct of the Promotion, the Promoter reserves the right in its absolute discretion to take any action that may be available to it, subject to State regulations, including cancelling, terminating, modifying or suspending the Promotion.
19. Any entrant who, in the opinion of the Promoter, tampers or interferes with the entry mechanism or Draw in any way, engages in any unlawful or improper conduct which jeopardises or is likely to jeopardise the fair or proper conduct of the Promotion, or who does not properly comply with the entry process, will be ineligible to win.
20. Incomplete, illegible, indecipherable or incorrect entries are not eligible to win.
21. The Promoter reserves the right to disqualify entries in the event of non-compliance with these Terms. The Promoter's decisions in relation to all aspects of the Promotion are final and binding on each entrant and no correspondence will be entered into.
22. The Promoter collects (and the Participating Outlets collects on the Promoter's behalf) personal information about entrants to include entrants in the Promotion and where appropriate award the Prize. If the personal information requested is not provided, the entrant cannot participate in the Promotion. By participating in the Promotion, each entrant consents to the Participating Outlets disclosing their personal information to the Promoter and the Promoter and the Participating Outlets using, and disclosing their personal information to the Promoter's related entities, the Promoter's or the Participating Outlets' agencies and other third parties engaged to provide services in connection with the Promotion (including suppliers of Prizes) for use for, the following purposes:
 - (a) contacting the entrant in relation to the Promotion;
 - (b) improving the Promoter's, the Promoter's related entities' or the Participating Outlets' goods and services; and

The Eligible Entrant provides this consent until such a time as they withdraw their consent by giving notice to the Promoter. Eligible Entrants can also gain access to, update or correct any personal information held by the Participating Outlets by contacting the Participating Outlets. All personal information will be stored at the office of the Promoter and/or the Participating Outlets as the case may be. Cardholders must have a contact method listed on their card for competition purposes and have all contact details up to date and correct.

23. The:
 - (a) Promoter, the Promoter's related entities, the Participating Outlets, and all agencies associated with the Promotion; and

- (b) the employees, agents, directors and contractors, of all entities referred to in paragraph 23(a),

shall not be liable for any loss or claim, action, demand, liability, damage, cost, expense or personal injury whatsoever (including but not limited to any direct, indirect or consequential loss), incurred, suffered or sustained by any person or entity (without limitation) in connection with, or arising from, the Promotion or the acceptance or use of, or participation in, the Prize, except that which cannot be excluded by law (in which case that liability is limited to the maximum extent allowable by law).

Lion-Beer, Spirits & Wine shall not be liable for any loss, damage or injury suffered by any winner as a result of the winner accepting and/or using a prize, except for any loss, damage or injury which is due to the negligence or wilful misconduct of Lion-Beer, Spirits & Wine or which otherwise cannot be excluded by law.

24. Eligible Entrants agree and acknowledge that all entries and any intellectual property rights subsisting in their entries become and remain the property of the Promoter.
25. Each entrant acknowledges and agrees that it is a condition of participation in the Promotion that the entrant be capable of agreeing to these Terms and giving the consents contained herein.
